The meeting was called to order by Ann Juranek, President at 4:00 P.M. The Pledge of Allegiance was led by Anne. A welcome speech was given by Ann Juranek. Self introductions of all the family members followed. It was moved by Dale von Rosenberg and seconded by Art Green to dispense with the reading of the Minutes.

The Treasurer's report was given by William von Rosenberg III. The combined Book & Operating Fund had a beginning balance of \$1,616.58, receipts of \$6,737.05, expenses of \$1,835.02, and a balance of \$6,518.61. It was moved by Wayne Scholz to accept the treasurer's report, Bill von Rosenberg, Jr. seconded, and the motion passed.

Dale U. von Rosenberg presented the following historian's report:

- (A) In 1863, Charles (I-1, born 1850) and Arthur (I-2, born 1851) worked in a Percussion Cap Factory in Austin in filling caps for the Confederate forces. On February 28, Charles was paid \$14.25 for filling 14,240 caps during 18 days that month. Above information in footnote in article by James Patrick McGuire on Texas printmakers.
- (B) Read in Land of Good Water, history of Williamson County, about opening of Hermann Helmuth-von Rosenberg store in Coupland; confirmed in red book. Hermann Helmuth was the grandson of Johanna von Rosenberg Helmuth (II). He married a grand-daughter of Johannes von Rosenberg (III).
- (C) Received additional information about the Eckitten Estate from Inge Schmidt of Hamburg. This information includes a map showing the location of Eckitten and of other estates mentioned in the biographies in Vol I (blue book). Information included.
- (D) On June 18, my brother and I attended a dinner held by the English-Speaking Union in Houston in commemoration of the 182nd anniversary of the Battle of Waterloo. We were introduced as descendants of Peter Carl von Rosenberg, who fought in the battle; we were the only descendants of a battle participant attending.
- (E) From my nephew, John von Rosenberg, I obtained more information about the White Lady, discussed on page 2 of the Blue Book. Information from (Dictionary of Phrase and Fable http:// www.bibliomania.com/Reference/PhraseAndFable/index.html). White Lady of German legend - A being dressed in white, who appears at the castle of German princes to forebode a death. She last appeared, it is said, in 1879, just prior to the death of Prince Waldemar. She carries a bunch of keys at her side, and is always dressed in white. The first instance of this apparition occurred in the sixteenth century, and the name given to the lady is Bertha von Rosenberg (in Bohemia). Twice, we are told, she has been heard to speak, once in December, 1628, when she said, "I wait for judgment!" and once at the castle of Nuehaus in Bohemia when she said to the princess, " 'Tis ten o'clock."
- (F) Other actions of the Historian: At the request of the President of the Association, I prepared a description of the duties and responsibilities of the Historian. I talked with Ray von Rosenberg, my predecessor as Historian. He has considerable amount of family material. We must work out a place to store this and have it cataloged.

A motion to approve the Historian's report was made by Nettie Green and seconded by Bill von Rosenberg, Jr. The motion carried.

Under Old Business, Wayne Scholz, Secretary explained that many family tree worksheets have been received. Wayne encouraged all present to be sure and complete their family worksheet. The worksheets received thus far have not been placed in a database that he h created. Wayne also asked for corrections to incorrect mailing addresses. Ann Juranek announced that we have 700-800 cookbooks remaining to sell and that she encouraged new marketing ideas. Bill von Rosenberg, III said that we still have some v.r.
