

## Original Emigration Journals of the von Rosenbergs to Texas Resurface after 160 Years

The original 1849-1851 "Emigration Journals" of the von Rosenberg family from Germany to Texas including the family's initial settlement at Farm Nassau appeared miraculously this past summer among the donated documents and photographs that had been a part of the collections of Robert Hein's mother, Mrs. Paula Hein of San Antonio, grandfather, Mr. Paul Meerscheidt of San Antonio and grandaunt, Miss Martha Meerscheidt, also of San Antonio.

The journals are in three separate, blue covered volumes trimmed in a decorative strip over its bound edge. They are all in excellent condition. Each measures 8  $\frac{1}{4}$ x 7 inches and are tied together with string, and the third volume still includes its original pink-colored ink blotter. Entries are written by the Pioneer Father and Mother, Peter "Carl" and Amanda von Rosenberg, and two children, Wilhelm and Lina.

Each journal is approximately <sup>1</sup>/<sub>4</sub> inch thick. They were sent from Koenigsberg, Germany in 1935 to Miss Martha Meerscheidt of San Antonio, Texas. The journals were never letters that were individually mailed but were rather a family

travel diary, which also included the first two years of settlement at Farm Nassau.

It appears that the journals were eventually sent to Germany to be shared among Froelich and Fallier family members in order to prepare anyone contemplating a move to the Americas of what to expect during the voyage and upon arrival.

The originals will be on display at next year's Reunion and then donated to the Fayette Library and Heritage Museum & Archives in La Grange. Copies of the same will be made in advance so that these Journals and their translations will be available through our family store to all descendants and historians.

## In Search of Alex von Rosenberg A Day-Trip to Liberty

The cross marks the spot. Located directly between and at the very foot of the graves of the two pictured grave monuments is a small rectangular-shaped piece of granite, which marks the location where the head of a cast iron casket is buried. The casket was accidently discovered in 1940 and has been speculated to be the burial location for the Civil War soldier Alex von Rosenberg, son of Peter Carl and Amanda von Rosenberg of Round Top, Texas.


Neale Rabensburg became intrigued with his 2nd great granduncle, Carl Alexander von Rosenberg, after he came across 1980 documents in the La Grange, Library, which speculated on the remains as that of Alex von Rosenberg.

After numerous attempts to contact people, institutions and businesses associated with the 1940 discovery and a court ordered exhumation and examination that followed in 1971, Neale decided that it was necessary to make a day-trip to Liberty, Texas and size things up for himself.

During his visit to Liberty, Neale was met by Sandra Pickett, former head of the Liberty County Historical Commission, who had been an active member of that organization during the time of the 1971

## Cast Iron Casket Twice Exhumed in Liberty, TX. Is this the Lost Grave of Alex von Rosenberg?

Is the body inside this elaborate cast iron casket with a glass viewing window our great granduncle, Carl Alexander von Rosenberg, who died in a Liberty, Texas military hospital during the Civil War? At least some citizens of Liberty County have speculated as much!

The casket was accidently discovered in 1940 at the Old Catholic Cemetery in the town of Liberty. Interest in this mysterious casket and the body inside persisted until December 1971 when it was exhumed for a second time by court order and with permission from the Bishop of Beaumont.

Nine years after the second exhumation in 1980, Miss Sallie Woods of the Liberty County Historic Commission contacted Mr. Walter Freytag of the Fayette County Historic Commission with drawings and a photograph of the casket including information referencing Alex von Rosenberg, who died in a Liberty military hospital on October 2, 1864. Miss Woods had deduced that there was a strong possibility that the remains were that of Alex von Rosenberg of Round Top, Texas.

By the spring of 1864, Sergeant Carl Alexander von Rosenberg and his younger brother, Corporal Walter von Rosenberg, sons of Peter Carl and Amanda von Rosenberg, had already served the Confederacy courageously for several years defending the Texas and Louisiana Gulf Coasts against Union gunboat attacks and military invasions. The two brothers were

members of Cruezbauer's Battery, 5th Texas Artillery, which had defeated a Union naval force of two gunboats and captured about 200 men at the Battle of Calcasieu Pass in May of 1864. Alex and Walter had gone home to Round Top on their first furlough since the beginning of the War shortly after the battle and then rejoined their unit that summer at Cat Springs before returning to Liberty.

Later that summer, Alex von Rosenberg and many of his fellow comrades contracted Yellow Fever. Most recovered, but Alex grew worse and was admitted into a military hospital in Liberty on September 4, 1864. His company received orders to pull out of Liberty, but Alex was too sick to travel. His condition grew steadily worse, and he finally succumbed to a merciful death at the age of 31 years on October 2, 1864. He was reportedly buried in a cemetery near Liberty.

Alex von Rosenberg "was loved by all family members, and many sons of



later years bore his name." If Alex had survived the War and been able to marry and have chil-

dren, then his family line would have been recognized as Branch VI of the von Rosenberg Family of Texas.

## Ray von Rosenberg Parts with Some of His Family Historical Data

Von Rosenberg family historian committee members, Billye Beth Baker (Branch IV) and Neale Rabensburg (Branch V), drove to Temple, Texas from La Grange in mid-August 2010 in order to share with Ray von Rosenberg (Branch VII) some of the recently acquired historical documents including the original 1849-1851 emigration and settlement journals of the von Rosenberg family to Texas from Germany. Ray, who was the Historian for the von Rosenberg Family immediately prior to Dale U. von Rosenberg, was unable to attend this past summer's gathering of the family at Camp Lone Star.

The three spent much of the day going through each other's historical data. Ray brought out the Civil War sword that had been Corporal Walter von Rosenberg's (Branch VII) when he served with Cruezbauer's Battery and the 5th Texas Artillery. The bone handle is engraved with Walter's name and the date of 1862.

Billye Beth and Neale were a bit overwhelmed when Ray pulled from his bookshelves numerous binders from his own personal collection of von Rosenberg family material and instructed his two visitors to return with his material to La Grange and add them to the family archives. Significant among Ray's own written histories was also an original copy of the 1909 *Familie Froelich* by Reinhold Froelich. This is a complete copy written in German featuring a number of related family lineage foldout charts including those von Rosenberg's, who came to Texas.

The von Rosenberg Family is very grateful to Ray for his generous donation of family material. However, he continues to send more, which will also be added to the Family's archives. The Ray von Rosenberg Collection will be on display at next year's Reunion and then donated to the Fayette Library and Heritage Museum and Archives.

## Robert Hein Donates Historical Documents at 2010 Reunion

Members were pleased to welcome after a long absence Robert Hein (Branch V) and his wife, Nancy, to this past summer's Reunion. Before their departure on Saturday, Robert presented President Neale Rabensburg with a large plastic storage container of family documents that had been in the possession of his mother, Mrs. Paula Hein.

Neale had to wait until after the conclusion of the Reunion on Sunday before examining the container's content. He was pleased to see numerous old documents and photos including three, small blue-covered bound papers of handwritten letters. It did not take him long to recognize that these were perhaps old copies of the emigration journals of the von Rosenberg family from Germany to Texas.

Initially, Neale could not accept the possibility that these journals may actually not be old copies but rather the original journal entries made by the pioneer mother and father, Amanda and Peter Carl von Rosenberg, and two of the children, Wilhelm and Lina, beginning with the 1849 voyage aboard the Franziska and terminating two years later with the family's settlement at Farm Nassau. Realization that these were indeed the original journals finally began to take hold over the next several days following the Reunion.

Also, of special note in the box of documents were biographies and lineage charts that had been used for the development of the Red Book (Volume II). The box also contained minutes and account records of the early days of the Reunion beginning with the first gathering of descendants of the von Rosenberg family in 1939 at Round Top.

The Robert Hein Collection will be on display at next year's Reunion and then donated to the Fayette Library and Heritage Museum and Archives.

## "Free-thinkers" J.T. Koenig, vR Historian's **Committee Member**, Will Make It Official

J. T. Koenig (Branch IV) has agreed to work with his fellow vR Family historians and prepare a written statement of opinion that could be adopted as the official position for The von Rosenberg Family of Texas with regards to the subject of "freethinkers" (German: "freidenkers"), and, more importantly, how the concept of freethinking or free-thought, was defined by members of the von Rosenbergs at the time of their emigration from Germany to Texas.

Since the principles of free-thinking had been applied to an array of established dogmas, the meaning of free-thinking varied across the countries of Europe. To many, it was a rejection of religious dogma while to others, it took the form of a rebellion against autocratic forms of government in favor of representative rule.

The von Rosenbergs left Germany due to their stance on the principles of freethinking. We would not be here today if it were not for this thought process. Therefore, it should be important for all descendants of the von Rosenberg Family of Texas to have a clear and precise understanding of what it meant to have been a von Rosenberg freethinker in the mid-19th Century.

exhumation. She shared with Neale her records from that time period. Both met with Darlene Mott, acting Director of the Sam Houston Regional Library and Research Center (Sam Center), and reviewed the file of historian and attorney, Charles W. Fisher, Sr., who was directly involved with the 1971 exhumation and examination. Mr. Fisher's records of the 1971 exhumation had been donated to the Sam Center.

After his trip to Liberty, Neale concluded that the evidence falls short for support of the theory that the remains in the cast iron casket are that of Alex von Rosenberg. Only a third exhumation and DNA testing would provide the necessary proof that the remains are indeed Alex or someone else. This seems unlikely since such a course of action might have to follow procedures taken in 1971, which required a court order as well as permission from Catholic Church hierarchy.

The cast iron casket and body inside were apparently in good condition at the time of the first exhumation in 1940. The air tight seal of the casket was intact but became compromised during the removal when the glass viewing window was accidently cracked allowing air to enter the casket, causing the remains inside to slump. The body had been visible through the glass but only for a brief moment and was reportedly clad in a military uniform. Photos taken during the first exhumation indicate that the casket was entirely soldier, who was revered for many years.

removed from the ground, but apparently not opened for a thorough examination. It was reburied that same day upon orders from the Church.

#### The second exhumation that finally occurred in December 1971 was years in the making and involved a number of people, institutions and businesses. Interest in the cast iron casket and the body inside was revived by members of the Liberty County Historical Commission, who petitioned the Catholic Church for permission to exhume the casket and examine the remains. This group was trying to attain historical status from the State for the old Catholic Cemetery, and it was deemed important that more information about the cast iron casket and the remains inside be brought to the surface *literally*.

Neale found the official examination report in December 1971 lacking in details. It did not indicate whether or not the upper half of the casket was actually removed. File photos do not show the two halves separated. therefore, it would have been difficult to examine the remains below the chest through just the viewing window. The report, however, indicates that there was no visible evidence of clothing with the exception of one wooden button that had been mounted to a decorative leaf pattern. These objects were resting over the rib cage at the sternum. No sword was inside even though this was reported to Neale by Ed Pickett during an earlier conversation.

There was a newspaper article about this 1971 exhumation in one of the local Liberty newspapers, according to Charles Fisher, Jr. son of attorney, Charles W. Fisher, Sr. Neale was told that the Sam Center has microfilm copies of both local newspapers but unfortunately, the issue needed was missing from their files. Another possible source, Mary Urban, who is the lone surviving evewitness to the 1971 exhumation and examination, was unavailable and in a local hospital at the time of Neale's visit and her diagnosis, according to her son, was very serious.

Neale continues to explore other avenues and sources and hopes that one day, a document will surface that will shed new light on the details surrounding Alex's burial. A fitting recognition is in order for this brave




